Subject:- (i) Consideration of request of BSNL employees in the Cadre of JTOs/SDEs/JAOs/AOs/TTAs/JEs recruited on DoT/DTS/DTO, 1999/2000 notification (prior to the formation of BSNL) - Grant of all benefits under CCS (Pension) Rules, 1972- reg.

(ii) Inclusion of Central Government employees recruited against the posts/vacancies advertised/notified prior to 22.12.2003, under Central Civil Services (Pension) Rules, 1972 (now 2021)- reg.

With reference to above subject (i) and (ii), with great gratitude, your kind attention is invited to Bharatiya BSNL Officers Association (in short BBOA) National Ideology letter to DoPT, Govt of India dated 30.11.2023 mentioned above, vide which it was requested to kindly consider grant of benefits under CCS (Pension) Rules, 1972 to the Cadre of JTOs/SDEs/JAOs/AOs/TTAs/JEs recruited on DoT/DTS/DTO, 1999/2000 notification (prior to the formation of BSNL) in accordance to Govt. of India, Ministry of Personnel, Public Grievances and Pensions and Department of Pension of Pensioners' Welfare letter Dated 03.03.2023 and dated 07.11.2023.

2. In this regard, it is to intimated that one Advertisement was issued by Andhra Pradesh Telecom Circle under Department of Telecommunication Services Govt. of India, dated 10.04.2000, INDIAN EXPRESS, HYDERABAD, ANDHRA PRADESH (Advertisement copy attached), wherein officials were recruited in BSNL instead actual recruitment in Department of Telecommunication, Govt. of India and denied all Govt. benefits by DoT / BSNL till date. Now, also they have not been given one time option for benefit under CCS (Pension) Rules 1972 in accordance with guidelines/instructions issued by DoPT vide OM dated 03.03.2023 (at ref. -5). Such officials without any fault were deprived from their benefits/rights under Govt. of India.

3. Similar Advertisements were issued by all Telecom Circles in India under Department of Telecommunication Govt. of India to the Cadre of JTOs/SDEs/JAOs/AOs/TTAs/JEs recruited on DoT/DTS/DTO, 1999/2000 notification (prior to the formation of BSNL)

4. Bharatiya BSNL Officers Association (in short BBOA) National Ideology vide letter No. BBOA/Welfare/CHQ/MOC&IT/2022-23/23 dated 06.04.2023 and No. BBOA/Welfare/CHQ/MOC&IT/2022-23/57 dated 06.07.2023 requested Shri Ashwini Vaishnow Ji, Hon'ble Ministry of Communication and Railway, for kind consideration on humanitarian ground for the grant of PENSION benefits under CCS (Pension) rule 1972 to BSNL Employees recruited vide DoT/DTS/DTO notification 1999/2000, in accordance to Govt. of India, Ministry of Personnel, Public Grievances and Pensions and Department of Pension of Pensioners' Welfare letter Dated 03.03.2023 and dated 07.11.2023.

5. Considering associations various requests and representation of affected Employees, DoT vide letter dated 04.08.2023 with copy to Shri Kirti Kumar Sharma, General Secretary and Shri Rajender Singh Tushir, Chairman/Patron Bharatiya BSNL Officers Association (in short BBOA) National Ideology, directed CMD, BSNL Corporate office, Bharat Sanchar Bhawan Janpath, New Delhi to decide/consider the request of BSNL employees in the cadre of JTOs/SDEs/JAOs/AOs/TTAs/JEs recruited on DoT/DTS/DTO, 1999/2000 notification (prior to the formation of BSNL) for grant of all benefits under CCS (Pension) Rules, 1972, in terms of the Guidelines/Instructions/OMs/Letters issued by DoT from time to time. So far no reply/response received by this office.

6. In this regard, BSNL Administration till date has not responded to DoPT/DOT guidelines for grant of benefit under CCS (Pension) Rules 1972 to employees recruited under 1999/2000 notification (prior to formation of BSNL). Whereas DOT vide OM No. 36-03/2019-Pen(T) dated :17.04.2023 has endorsed DoPT guidelines dated 03.03.2023 to all Govt. Offices including Telecom PSUs (BSNL/MTNL) for effective and immediate implementation of their orders.



Since BSNL Administration has not replied till date, to Shri Kirti Kumar Sharma, General Secretary and Shri Rajender Singh Tushir, Chairman/Patron Bharatiya BSNL Officers Association (in short BBOA) National Ideology, even when clear instructions/guidelines have been issued by DoPT and DOT, Govt. of India, it is requested to kindly consider all such cadres JTOs/SDEs/JAOs/AOs/TTAs/JEs recruited on DoT/DTS/DTO, 1999/2000 notification (prior to the formation of BSNL), as Govt. recruited employees in Department of Telecommunications and granted one time option to be covered under the CCS (Pension) Rules, 1972. Option form may kindly be issued to the affected Employees by DoPT, who were deprived from their right/benefits till date.

Bharatiya BSNL Officers Association (in short BBOA) National Ideology has full faith in the great leadership of Hon'ble Prime Minister, Government of India, Shri Narendra Modi Ji who is working very hard and fully dedicated for the wellbeing and welfare of poor and deprived people. Beside this, lots of good works have been done by the present Government of India since 2014, which are very noble and appreciable.

Sir, considering above facts and various letters/guidelines issued from DoPT and DoT mentioned under reference 1 to 7 above, necessary/ appropriate decision may kindly be taken immediately please on the humanitarian ground for the welfare of Employees. Bharatiya BSNL Officers Association (in short BBOA) National Ideology will be very thankful for your kind implementation as above under intimation to this office..
